Author Rights

The author, project title and area (field of knowledge) are mentioned on the website. The name of the PDF for free download makes reference to the author's intellectual property as ©**Author**.

What are Author Rights?

People often use the terms “author rights” and “literary rights” to mean copyrights, the legal rights attached to certain types of intellectual property. **Lugânzi — The Living Archive**© interprets copyrights as per the Angolan Law on Copyrights and Related Rights (see PDF, *Lei n° 15/14, Dos Direitos de Autor e Conexos*).

Please consult the law to find out your rights, duties and obligations as an author. The law covers both Angolan authors and those whose work is produced, published or presented, for the first time, in Angola, or published in Angola, within 30 days of being published elsewhere, regardless of the nationality and residence of the author.

Briefly put, only the owner of a copyright has the right:

1. **To reproduce the work:** e.g., make physical or digital copies of your work for colleagues, students, or others;
2. **To prepare derivative works based upon the work:** e.g., prepare a subsequent article, chapter, or book that builds upon their original or prior research on a particular topic;
3. **To distribute copies of the work:** e.g., distribute physical or digital copies of your work to colleagues, students, or at conferences;
4. **To publicly perform the work:** e.g., show video of your field work in the classroom or at conferences;
5. **To publicly display the work:** e.g., show photos, exhibits, and figures from your works in the classroom or at conferences;
6. **To publicly perform sound recordings via a digital audio transmission:** e.g., for those working with sound recordings, to digitally transmit your work (broadcast online, etc.)

However, because knowledge and society would fail to progress if only a copyright owner could engage with copyrighted works, **Lugânzi — The Living Archive**© and **The Living Libraries**© asks authors to permit the use of their copyrighted works, within the framework of the Angolan Law 15/14 on Copyrights and Related Rights.

In short, the copyright owner still owns the work and the copyright in it, but by publishing at **The Living Libraries**©, she, he or they permit others to use the work under certain circumstances.

Please note that **The Living Libraries**© may publish works whose copyright has already expired — e.g., currently 70 years after the death of the author in the absence of heirs — and the public can use the work in any way they desire.



Lugânzi – The Living Archive© and The Living Libraries© do not, for the time being, enter into contracts with authors, though authors have the power and right to negotiate, for the publication of their work, individual written or spoken agreements with **Lugânzi – The Living Archive© and The Living Libraries©** in accordance with the Angolan Law 15/14 on Copyrights and Related Rights.

Publishing at **The Living Libraries©** in no way gives the platform’s Author Rights, merely the right to publish Copyrighted work.

Therefore, authors should be aware that their work, available for free download, may be:

1. **Reproduced by website users:** e.g., physical or digital copies may be made and shared with friends, colleagues, students or others;
2. **Used to prepare derivative works based upon the work:** e.g., a subsequent article, chapter, or book that builds upon the author’s published work may be prepared by a website user;
3. **Distributed as copies by website users:** e.g., physical or digital copies may be made and shared with friends, colleagues, students or others;
4. **Performed by website users:** e.g., uploaded videos of your field work or research may be downloaded or copied by website users and displayed in classrooms, conferences, other public or private events or other websites or online platforms;
5. **Displayed by website users:** e.g., published photos, exhibits, and figures from your work may be shown by website users in classrooms, conferences, other public or private events or other websites or online platforms;
6. **Recorded and/or rebroadcasted by website users:** e.g., for those working with sound recordings, your work may be digitally recorded and/or transmitted (broadcast online, etc.).

Lugânzi – The Living Archive© and The Living Libraries© publishes your work with the “© Author” visibly and legibly displayed on the published content, and encourages website users to know our *Fair Use* policy and respect Author’s Rights, by citing clearly and visibly the source of the material when used for the purposes described on points 1 to 6 above, in addition to other foreseeable purposes that may be similar or related to points 1 to 6 above.

Users are reminded that the free availability of works and related materials and content in no way gives them the right to violate intellectual property rights in the policy *Fair Use* (see PDF).

Lugânzi – The Living Archive© and The Living Libraries©, does not assume any responsibility for any use of the published material that may be regarded as failing to comply with or that may be regarded as immoral, unlawful or illicit under Law 15/14 on Copyrights and Related Rights, as well as used for purposes not foreseen in points 1 to 6 above.
